1. All proposals of 'Registration' and 'Eligibility' shall be submitted by the Colleges alongwith fees in the stipulated period as notified by the University from time-to-time, failing which late fees of Rs. 500/- per day shall be charged separately towards late submission of proposals as well as correct CD.
2. It shall be the responsibility of the Dean/Principal of the College to collect requisite fees from the concerned students and submit a consolidated Demand Draft in favour of the Registrar, MUHS payable at Nashik.
3. Reserved category candidates admitted in 'Open' quota are entitled to remit above fees prescribed for 'Reserved' quota; provided such proposals must be duly supported by Caste Certificate, Caste Validity Certificate and Non-creamy layer Certificate (if applicable). However, such relaxation will be restricted to proposals which are completed in all respect at the time of submission to the University. No request for refund of Registration and Eligibility fees shall be considered by the University at a later stage.
4. Quota-wise fees viz 'Open', 'Reserved' and 'NRI' has been prescribed by the University. Reserved category candidate admitted in 'NRI' quota is not entitled to claim fee relaxation prescribed for 'Reserved' quota.
5. Late fees of Rs. 50/- per week per student will be charged towards late submission of documents w.e.f date of communication by the University.
6. Fees once paid shall not be refundable or transferable.
7. Eligibility Notification No.03/2011, therefore hereby stands cancelled.
