Sub. : Further course of action to be taken by the concerned conventional Universities, colleges & students in context with the Notification No. 08/2011 dt. 11/30/2011 issued by the MUHS, Nashik.

In context with the transfer of Pre-1998 batch UG courses and Pre-2006 batch PG courses students from the conventional Universities of the State to the MUHS, Nashik, the following further course of action to be taken by the concerned Universities, colleges & students is as per the details given below :-

The concerned Conventional Universities to forward the following to the MUHS, Nashik

- 1) Nominal roll of UG course students (year/coursewise).
- 2) Nominal roll of PG course students (year/coursewise).
- 3) Admission eligibility of the students alongwith the relevant documents.
- 4) Present status of PG students' synopsis & Dissertation etc.

The concerned students to take the following action

- 1) Approach the concerned parent college for admission eligibility clearance.
- 2) Solve pending clearance if any from the college and for issuance of Bonafide certificate by the college.
- 3) Get attested the last exam marksheet.
- 4) Application to MUHS for further prosecution of course/appearing in exams alongwith necessary undertaking as per format given in Notification No. 08/2011 dt. 11/03/2011.
- 5) Go through the MUHS Rules/Regulations/Notifications etc. which are available on website www.muhsnashik.com
- 6) Various fees to be paid to the University through D.D. in favour of 'The Registrar, MUHS, Nashik' (Details of fees structure as notified in University notification/circular are available on website www.muhsnashik.com)

The concerned Colleges to forward the following to the MUHS, Nashik

- 1) Concerned students' applications alongwith their under taking certificates.
- 2) Students' admission eligibility clearance and Bonafide certificate.
- 3) Attendance record of Theory Classes & Practical/Clinicals.
- 4) Internal Assessment records/resultsheets.
- 5) Synopsis subject approval and Acceptance/Non-acceptance of Dissertation of PG students.
- 6) Exam forms of the eligible students to MUHS alongwith the exam fees through D.D. in favour of 'The Registrar, MUHS, Nashik' payable at Nashik.
