With reference to above cited subject & references, it is to inform you that, the Dissertations of all eligible PG courses candidates appearing for Summer-2012 examinations of above mentioned courses will have to be submitted/forwarded to respective MUHS Regional Centers/University, through the respective college representatives, course/subject wise between the dates along with prescribed fee as mentioned below:-

Sr. No.	Period	Fee
1	11 Feb. 2012 to 21 Feb. 2012	₹ 1800/- prescribed normal fee for each candidate
2	22 Feb. 2012 to 01 Mar. 2012	₹ 1800 + 600 late fee = ₹ 2400/-

The fee in the form of Demand Draft drawn on any Nationalized Bank in favour of “The Registrar, MUHS, Nashik” payable at Nashik, must be submitted along with the list of the candidates and Dissertations.

It is expected that the Dissertations are to be submitted between first scheduled dates with normal fee of ₹ 1800/-. However, the submission of Dissertations with late fee is for exceptional cases only, for which the proper and genuine reasons should be explained by the concerned candidate with comments and approval of respective colleges Dean / Principal / Director and Guide till 01 March 2012 only.

In any case the Dissertations will not be accepted after 01 March 2012 under any circumstances. (Board of Examinations resolution No.26 dated 24/02/2010.)

1. **Dissertations must be submitted as per guidelines given in the Notification as mentioned under reference.**
  2. **The Dissertations of the candidate's will be accepted only on fulfillment of following conditions:-**
    - a – Title & Synopsis of Dissertations is approved by University authority.
    - B – The candidate's final eligibility is confirmed by University authority.
    - C – In case change of guide, it must have the approval by University authority.
  3. The Principal, Godavari College of Nursing, Jalgaon will be submitting the Dissertations to the University (Faculty of Allied Health Sciences in Department of Post Graduate Examinations). Please bring this circular to the **Notice** of all concerned.
